**The Jacksboro Planning Commission met in regular session Thursday, June 4<sup>th</sup>, 2009 at 6:00 p.m.**

**Present: Connor, Forstner, Cannon and Cunningham.**

**Absent: Ronnie Weaver.**

**Mr. Connor had to leave the meeting on an emergency.**

**Also, present was Midge Jessiman with the State Planning Office, Clifford Ogg, Dwight Crutchfield and Bill Cox.**

**Motion made by Cannon second by Forstner to approve previous minutes. All present voted yes. (May 7, 2009 minutes)**

**Mr. Connor joined the meeting at this time. (6:09 p.m.)**

**Clifford Ogg and Dwight Crutchfield were present to request final approval of the site plan located on Myers Street for 6 (six) apartment units. Mr. Crutchfield presented to planning commission a 2, 5, & 10 year storm event which was certified. Midge Jessiman recommend that the entrance into the apartments be moved on the far left side (see site plan). Also if there are any water problems Mr. Ogg will be responsible. Motion made by Forstner second by Cannon to approve the site plan with recommendation from Midge Jessiman with the State Planning Office. All present voted yes.**

**Bill Cox was present to request final approval of the site plan located on Butter & Egg Road, Judge Asbury Court Subdivision will have 15 lots. Mr. Cox presented a new drainage plan to planning commission. Planning Commission requested that the 2 (two) cuts in the road be closed in, property owners can not cut the curbs on the road that goes into their driveways, add right turn only sign, added to the deed will be property owners can not cut the curb on the road that goes into their driveways and Mr. Cox will be responsible for any water problems. Motion made by Cannon second by Connor to approve the site plan with the entire request made by planning commission. All present voted yes.**

**Planning Commission had a workshop on Monday, June 1<sup>st</sup> at 6:00 p.m. to review the Land Use Plan.**

**Midge Jessiman with the State Planning Office discussed with Planning Commission the Land Use Plan and the Annual Report & Planning Program Design 2009-2010, also this will be added to July's agenda for approval.**

**The Jacksboro Planning Commission will hold a training session on Tennessee Main Street Program Tuesday, September 29<sup>th</sup> at 6:00 p.m. for all cities and county to attend the meeting will be held in the Jacksboro Municipal Building's meeting room.**
