

Board of Mayor and Alderman Meeting
September 1, 2005

The Board of Mayor and Alderman met in regular session on Thursday, September 1, 2005 at 7:00 P.M.

Present: Alderman Burden, Burrell, Forstner, Green and Mayor Cannon.

Motion made by Forstner second by Burden to approve previous minutes. All present voted yes.

Reports were submitted from the Library, Fire, Police and Street Department.

Mayor Cannon reported that the application for an aquatic alternation permit is ready to mail for approval to begin work in creeks on Cedar Lane and Springfield Subdivision to prevent flooding. Also, a one hour training session for employees is scheduled for October 28th on Drug Free Workplace.

Motion made by Cannon second by Forstner to approve the Comcast Cable Contract for a five (5) year period, amendments to the contract may be negotiated every two years and the new contract will be submitted 15 months before expiration to allow for negotiations. All present voted yes.

Motion made by Cannon second by Forstner to approve a website for the Town of Jacksboro at the cost of \$100.00 per year. All present voted yes.

Motion made by Forstner second by Cannon to approve the Librarian attending a workshop on September 29th. All present voted yes.

Motion made by Forstner second by Green to approve the Friends of the Library holding a book sale on September 26-30 at the library. All present voted yes.

Motion made by Cannon second by Burrell to approve purchasing an exhaust system for the 1994 Chevrolet street department vehicle from Kar Care at the cost of \$135.00. All present voted yes.

Motion made by Cannon second by Burrell to approve purchasing two (2) mobile radios for the police department at the cost of \$235.00 each. All present voted yes.

Motion made by Cannon second by Burden to approve purchasing emblems and ammunition for the police department. All present voted yes.

Motion made by Forstner second by Green to approve purchasing the list of items for the fire department at the approximate cost of \$241.00 All present voted yes.
